³ On December 25, 1991, the United States recognized the independence of Armenia, Azerbaijan, Belarus, Georgia, Kazakhstan, Kyrgyzstan, Moldova, Russia, Tajikistan, Turkmenistan, Ukraine, and Uzbekistan, the 12 republics that had constituted the U.S.S.R.

- ⁴ On April 7, 1992, the United States recognized the independence of Bosnia and Herzegovina, Croatia, and Slovenia, three of the republics that had previously formed constituent parts of Yugoslavia.
- ⁵ On January 1, 1993, the United States recognized the independence of the Czech Republic and Slovakia, separate states that had previously comprised Czechoslovakia.
- ⁶ On February 8, 1994, the United States recognized the independence of The Former Yugoslav Republic of Macedonia.
- ⁷ The Government of Portugal signed an agreement with China on April 13, 1987 returning Macau to Chinese administration effective December 20, 1999. As of December 20, 1999, Macau was designated as the Special Administrative Region of Macau, and the China-mainland chargeability became applicable to Macau.
- ⁸ Serbia and Montenegro have proclaimed the formation of a joint independent state, but this entity has not been formally recognized by the United States.
- ⁹ On October 1, 1994, the Trust Territory of the Pacific Islands (Palau) ended its status as a United Nations Trust Territory administered by the United States and became an independent state, in free association with the United States.
