**IMMIGRANT VISA MEDICAL EXAMINATION**

Immigrant, Fiance and LIFE Act visa applicants, regardless of age, must undergo a medical examination at a designated facility according to U.S. Public Health Service guidelines ([www.cdc.gov/ncidod/dq/health.htm](http://www.cdc.gov/ncidod/dq/health.htm)). The medical examination fee is US\$115 for adults and US\$75 for applicants under 15 in Mongolia. Fees for any required vaccinations are additional. Fiance and K3 visa applicants do not need vaccinations. It is the applicant's responsibility to arrange for a medical examination directly with the designated facility below.

Please give to the physician your passport and three passport size photographs which were taken within the last six months. The physician will give the medical report and chest X-ray to you in a large sealed envelope. DO NOT OPEN THIS ENVELOPE. The medical report is valid for 6 months, if a CLASS A or TB condition exists it is valid for 3 months from the time the evaluation is complete.

Your immigrant visa (IV) application is ready for final processing. If you are unable to come to your appointment, or if your address changes, please inform us by fax or mail. Your case will be terminated if you miss your appointment and have no correspondence from you for one year.

**WHAT TO BRING.** Each applicant, regardless of age, must apply with following documents. *Although only one copy of these documents is required, you may wish to obtain duplicates in case the originals are lost or damaged.*

**VISA VALIDITY.** IVs and fiancé visas are generally valid for six months for a single entry into the U.S. Life Act visas are issued for multiple entries for varying validities.

**YOUR APPOINTMENT.** It is your responsibility to come fully prepared with all needed documents in hand. Do not bring electronic or hazardous items. You and your belongings are subject to search. With the exception of children in the IR2, CR2 and F22 categories who are the principal applicants (not applying with parent(s), and all children resident in Mongolia, children under 14 years of age do not need to appear. You will be sworn-in as to the truth of your application. Please be patient as this is the first time we see your case in its entirety. If you are found eligible for a visa at the time of your interview, your visa will be given in two days. **DO NOT** make travel arrangements, dispose of your property, give up your job or sell your business until you have your visa in hand. Please apply well in advance of your desired travel to U.S.
