Appendix C

Offset in the Per-Country Numerical Level for China–Mainland Born Immigrant Visas (Per Section 2(d) of Pub. L. 102–404)

The Chinese Student Protection Act of 1992 (CSPA) (Pub. L. 102–404 enacted October 9, 1992) provides a basis for certain People's Republic of China nationals already living in the United States to obtain permanent residence through application to USCIS. Beneficiaries of this legislation are accorded status within the skilled worker component of the Employment Third preference and are subject to the worldwide Employment Preference annual limit. They are exempted from the INA 202 percountry limit, however. The CSPA requires that beginning with Fiscal Year 1993, the CHINA–mainland born per-country limit must be reduced by 1,000 numbers annually to compensate for cases processed under this legislation.
