FY1997 - 1) It was necessary to oversubscribe the F1 category in October. The main reason for this is the naturalization of F2B petitioners during the long wait between petitioning and visa issuance. Naturalization automatically converts an F2B case to the F1 category. The priority dates of such cases tends to be early. 2) In August it was necessary to retrogress the F1 cut-off date in an attempt to hold issuances within the annual numerical limits.

FY2000 - 1) FY-2000 December/January movements were limited because of potential Y2K problems.

FY2001 - 1) In July it was necessary to retrogress several cut-off dates in an attempt to hold issuances within the annual numerical limits. 2) Many categories became unavailable because the limits had been reached.

FY2002 - 1) It was necessary to retrogress the F1 cut-off date in an attempt to hold issuances within the annual numerical limit. The subsequent decline of INS (now CIS) demand allowed for forward movement in August and September.

FY2006 - 1) It was necessary to retrogress the F1 cut-off date in July, August, and September in an attempt to hold issuances within the annual limit. 2) The annual limit for F2A was reached in July.

FY2011 - 1) It was necessary to retrogress the F2A cut-off date in January and March in an attempt to hold issuances within the annual limit.

FY2014 - 1) It was necessary to retrogress the F2A cut-off date in June in an attempt to hold issuances within the annual limit.

FY2017 - 1) It was necessary to retrogress the F1 and F4 cut-off dates in September in an attempt to hold issuances within the annual limit.

FY2018 - 1) It was necessary to retrogress the F1 and F3 cut-off dates in September in an attempt to hold issuances within the annual limit.
