ATTENTION

The U.S. Embassy in Cairo has been designated to conduct immigrant visa services for residents of Sudan. Visit <u>U.S. Visa News</u> for additional information. Immigrant visa applicants should review the <u>U.S. Embassy in Cairo page</u> for additional instructions. Applicants with appointments currently scheduled should reach out to the National Visa Center using the <u>Public Inquiry Form</u> to request or confirm an appointment.

Please follow the steps below <u>before</u> your immigrant visa interview at the U.S. Embassy in Cairo, Egypt.

Step 1: Register your address online

You need to register your address online. This provides us with the information we need to return your passport and documents after your interview. These will be sent to an SLS office of your choice at no additional charge. Click the "Register" button below and print two copies of the confirmation page once you are done

 You must bring two copies of the confirmation on the day of your visa interview. If you fail to bring the confirmation page(s) on the day of the interview or do not include information related to all of the people and passports, your interview will be rescheduled.

Step 3: Complete your pre-interview checklist

It is important that you bring all required original documents to your interview. We've created a checklist that will tell you what to bring. Please print the checklist below and bring it to your interview along with the listed documents.

You must bring the <u>exact same document</u> that you submitted to NVC to the Interview Failure to do so will require your interview to be rescheduled, which will result in significant delays in the processing of your case.

Interview Guidelines

Medical Exam Instructions



The Immigration and Nationality Act requires that all immigrant visa applicants and certain nonimmigrant visa applicants undergo a medical examination prior to receiving a visa. The medical examination should be done by one of the authorized physicians listed below. Physicians will refer you to a syphilis testing laboratory. Applicants are advised to schedule their medical examinations 3 weeks prior to the date of the visa interview. Please bring the results to your visa interview. Please do **NOT** open your results!

IMPORTANT NOTE

The validity of your visa will be limited to the length of validity of your medical report. Travel clearances are valid for 6 months from the time the evaluation is complete for applicants who have no Tuberculosis Classification or Class B2 TB or Class B3 TB. Travel clearances are valid for 3 months from the time the evaluation is complete for applicants who are Class B1 TB, Pulmonary or Class B1 TB, Extrapulmonary. All applicants aged 18 to 44 years must be tested for evidence of syphilis.

Applicants who do not travel within the clearance period will need to restart the whole process. Any applicant diagnosed with pulmonary or laryngeal tuberculosis who needs treatment is not cleared to travel until completion of successful treatment, regardless of the diagnostic criteria. Please contact the panel physician for further information.

Requirements:

You must have **your CEAC confirmation page** in addition to your appointment confirmation and your valid travel document (passport/s) along with three passport-size photographs of each person to be medically examined, in order to complete the medical exam.

If you suffer from a chronic illness, have been treated for any disease, or are under psychiatric care, you should present your medical file during examination.

VACCINATION REQUIREMENTS:

United States immigration law requires immigrant visa applicants to obtain certain vaccinations (listed below) prior to the issuance of an immigrant visa. Instructions and procedural guides direct panel physicians who conduct immigrant visa medical examinations to verify that applicants have met the vaccination requirement, or that it is medically inappropriate for the visa applicant to receive one or more of the listed vaccinations:

Mumps, Measles, Rubella, Polio, Tetanus and Diphtheria Toxoids, Pertussis, Influenza Type B (HIB), Hepatitis A, Hepatitis B, Varicella, Pneumococcal, Influenza, Rotavirus.

To assist the panel physician, and to avoid delays in the processing of an immigrant visa, all immigrant visa applicants should have their vaccination records available for the panel physician's review at the time of the immigrant medical examination. If you do not have a vaccination record, the panel physician will work with you to determine which vaccinations you may need to meet the requirement. Certain waivers of the vaccination requirement are available upon the recommendation of the panel physician. Only a physician can determine which of the listed vaccinations are medically appropriate for you, given your age, medical history and current medical condition.

Medical Exam Instructions

The blood test and X-ray are generally not required of persons under the age of 15, but they are required, under united States law, of all other persons. You must undergo the medical examination at least ten days prior to your scheduled appointment at the Consulate. Failure to do so may result in processing delays.

- Effective October 1, 2016, All applicants aged 18 to 24 years must be tested for evidence of gonorrhea.
- Applicants aged less than 18 years or greater than 24 years must be tested if there is a reason to suspect infection with gonorrhea.

Items to bring to your medical examination

Bring the following items to your medical exam:

- Your visa interview letter,
- Your passport,
- Three (3) recently taken passport-sized color photographs,
- A copy of your immunization records, and
- Medical records, including prescription information, for any medical conditions you currently have.
- DS-260 confirmation page

Medical Exam Instructions



You must pay all medical examination fees, including x-ray and blood test fees, directly to the examining physician. Current fees are posted on our <u>website</u>.

During the medical exam

The medical examination will include a medical history review, physical examination, and chest X-ray, gonorrhea test, and blood tests (for applicants 15 years of age or older). The United States also requires tuberculosis (TB) testing for all applicants two years of age and older. Please be prepared to discuss your medical history, medications you are taking, and current treatments you are undergoing. More information on general medical requirements for U.S. immigrants is available from the Center for the Disease Control and Prevention. U.S. immigration law requires immigrant visa applicants to obtain certain vaccinations prior to the issuance of a visa. Current immigrant visa vaccination requirements are available CDC's website. You can also read Frequently Asked Questions about our medical examination requirements Travel.State.Gov.

After the medical exam

When your examination is completed, the doctor will either provide you with exam results in a sealed envelope or send them directly to the U.S. Embassy. **IF GIVEN AN ENVELOPE TO CARRY TO YOUR INTERVIEW, DO NOT OPEN THIS ENVELOPE. Instead, bring it to your visa interview.** Any x-rays taken will be given to you. You **DO NOT** need to bring the x-rays to your visa interview unless you suffer from tuberculosis (TB). However, you **must** carry the x-rays with you when you travel to the United States for the first time. The medical report must be less than six months old when you enter the United States as an immigrant.

Sending documents to the U.S. Embassy in Cairo

If the U.S. Embassy requests additional information or documentation from you, please visit our online <u>Visa Customer</u> Service and ask for information on courier services.

Rescheduling or cancelling your interview

If you are unable to attend your appointment, please contact our online <u>Visa Customer Service</u>. There may be a significant wait before the next available appointment, so please attempt to attend the date already assigned. For some family-based and employment preference visa categories, a visa became available within the month you have been scheduled by NVC. DV applicants should be aware that visas are numerically limited and must be issued by September 30 of the program year. There is no guarantee that a visa will still be available on the date of your rescheduled interview. Please carefully consult the <u>Visa Bulletin</u> before you decide to reschedule your interview.

Please note: You need to register your original NVC/KCC appointment online before you can reschedule it. Rescheduling is only possible on a date <u>after</u> your assigned appointment.

Security screening procedures

All visitors to the U.S. Embassy must follow certain security procedures. Any visitor who declines to be screened by U.S. Embassy security personnel will be unable to enter the embassy. To avoid delaying your entry and that of those in line behind you, please bring only what is required for your interview. Cell phones, electronics, large bags, and oversize items are not allowed into the embassy. Due to space limitations, do not arrive before your scheduled appointment.

Accompanying persons

Attorneys are **not** permitted to accompany clients into the waiting room or to their interview. The following persons may accompany a visa applicant to their interview:

- Interpreter: Applicants may bring ONE interpreter if they do not speak English or Arabic well enough to participate in an interview.
- Special Needs Visitors: Applicants may bring ONE person to help if they are elderly, disabled, or a minor child.

Immigrant visa fees

If you have not paid all required fees to either the National Visa Center or via the appointment website, please be prepared to pay these fees on the day of your interview. All fees may be paid in either U.S. dollars or the Egyptian dollar equivalent. We accept cash and credit cards only. *Please note that if you are found ineligible to receive a visa, the application fee cannot be refunded*. Interview Guidelines



If your visa is approved, we will keep your passport at the embassy while we prepare your immigration packet and print a visa for your passport. We will return your passport to you only via a free courier service to an Aramex office of your choice (see Step 1). If you have to travel within Egypt while your passport is still with us, please make sure you have a valid picture ID other than your passport.

After Your Visa Interview



A consular officer can make a decision on a visa application only after reviewing the formal application and interviewing the applicant. *There is no guarantee that you will receive a visa.* Do not sell your house, car or property, resign from your job or make non-refundable flight or other travel arrangements until you have received your immigrant visa.

If more information is needed

Sometimes a consular officer is unable to make a decision on a visa application because s/he needs to review additional documents, or the case requires further administrative processing. When additional documents are requested, the consular officer will give you a refusal letter that asks you to submit additional documents. The letter will include instructions on how to send those documents to the embassy.

Administrative processing takes additional time after the interview. Most administrative processing is resolved within 90 days. However, the timing varies based on the circumstances of each case. Before inquiring about the status of administrative processing, please wait at least 90 days after your interview.

What happens after visa approval

Passport, Visa, and Sealed Immigrant Packet – We will place your immigrant visa on a page in your passport. Please review your visa to make sure there are no spelling errors. We will also give you a sealed envelope containing documents that you must give to U.S. immigration authorities when you arrive in the United States for the first time. Do not open this envelope. You must carry it with you; do not put it in your checked luggage. If you receive X-rays during your medical examination, carry those with you and give them to the U.S. immigration authorities. However, if your visa has an annotation that reads, "Docs in CCD" you case is electronic, and you will not receive an envelope.

USCIS Immigrant Fee – All individuals who are issued immigrant visas overseas must <u>pay an Immigrant Fee</u> to U.S. Citizenship and Immigration Services (USCIS) *prior to traveling* to the United States. This fee is for processing your residency status and printing your Permanent Resident Card. The only people exempt from paying this fee are: children entering the United States under the Hague Process, returning residents, and people traveling on a K visa.

When You Should Travel – You must enter the United States *before* the expiration date on your visa, which is usually six months from the date of printing. Your visa generally cannot be extended and all fees are nonrefundable. The principal applicant must enter **before or at the same time** as other family members with visas. Unless they are eligible for benefits under the Child Status Protection Act, children who are issued a visa before turning 21 years of age must enter the United States *before* their 21st birthday to avoid losing their immigrant status.

Getting a Green Card – Your Form I-551 Permanent Resident Card, also known as a green card, will be automatically mailed to the address in the United States that you write in your visa application form. This is a very important document that proves you have permission to reside in the United States. **Do not travel outside of the United States until you receive your Permanent Resident Card.** Once your card is issued, you should not stay outside of the United States for more than one year. If you do, you will lose your status as a Lawful Permanent Resident.

After Your Visa Interview



Children's Issues – In the United States, children are required to have certain vaccinations before they can enroll in school. We recommend that you bring your child's complete vaccination records with you to the United States. If your child is adopted, you have full custody as a result of a divorce, or you share custody with another parent, you should bring a copy of all applicable adoption or custodial papers from the authoritative court in your home country. You will need these papers (translated into English) for issues such as school enrollment, medical care, and eventual citizenship.

Diversity Visa Applicants – Additional Information



If you are interviewing for a Diversity Visa (DV), all of the above instructions apply to you. Please schedule and attend a medical examination prior to your visa interview; enroll in the required courier service; and gather the required documents.

Below are additional instructions that apply **only** to DV applicants.

Review your DV Lottery entry

Prior to your visa interview, we recommend that you review the data on your initial E-DV entry. On your initial E-DV application, you must have correctly entered your marital status. If you are legally married you must have listed your spouse, even if you are currently separated from him/her (unless your spouse is a U.S. citizen or Lawful Permanent Resident).

Additionally, you must have listed ALL of your living children who are unmarried and under 21 years old. This includes your natural children, your spouse's children, or children you have formally adopted in accordance with the laws of your country.

Failure to have listed an existing spouse or children at the time of your entry in the Diversity Visa lottery will result in the denial of your visa and visas for your family. Any fees paid to the U.S. government in support of your visa application(s) are nonrefundable. If you failed to include a child who had already been born, or a spouse to whom you were married when you entered the lottery, you should not proceed with the visa application. You can review the eligibility requirements online.
