

Please follow the steps below *before* your immigrant visa interview at the U.S. Embassy in Tokyo, Japan.

Step 1: Get a medical exam in Japan

As soon as you receive your appointment date, you must schedule a medical exam in Japan. Click the "Medical Exam Instructions" button below for a list of designated doctors' offices in Japan. Please schedule and attend a medical exam with one of these doctors before your interview.

Medical Exam Instructions



All immigrant visa applicants, regardless of age, require a medical examination prior to the issuance of a visa. Only a physician accredited by the U.S. Embassy can perform this exam. It is your responsibility to schedule a medical exam with one of the doctors listed below <u>before</u> your visa interview at the U.S. Embassy. Medical examination results from other physicians will <u>not</u> be accepted. Your medical case will be ready approximately five days after you were notified of your immigrant visa appointment. Please refrain from contacting panel physicians until five days after receipt of your appointment.

Note: Please refrain from visiting the panel physician's office if you have traveled outside of Japan and you have not completed the quarantine guidelines provided by the Japanese government, or if meet the following criteria:

- 1. Are sick and/or displaying flu-like symptoms such as coughing, fever, shortness of breath, etc.
- 2. Have been exposed to individuals known to have tested positive for COVID-19

The medical examination report is normally valid for maximum of six months.

Items to bring to your medical examination

The doctor will need the following items to complete the medical exam forms:

- Your visa interview letter and/or the CEAC DS260 confirmation page (barcode page only),
- Your passport,
- Four (4)* recently taken passport-sized color photographs, and
- A copy of your immunization records.

Any medical examination fees, including x-ray and blood test fees, must be paid directly to the examining physician. The cost for the examination varies by required tests. Contact lens-wearers should not wear lenses to the exam. Please bring your contact lenses and solution with you. **Please note that all immigrant visa applicants are required to fully disrobe during the examination.**

*Photographs are only required for DV and K visa applicants.

Medical Exam Instructions

During the medical exam

The medical examination will include a medical history review, physical examination, and chest X-ray and blood tests (for applicants 15 years of age or older). The United States also requires tuberculosis (TB) testing for all applicants two years of age and older. Please be prepared to discuss your medical history, medications you are taking, and current treatments you are undergoing. U.S. immigration law requires immigrant visa applicants to obtain certain vaccinations prior to the issuance of a visa. Current immigrant visa vaccination requirements are available <u>here</u>. You can also read Frequently Asked Questions about our medical examination requirements <u>online</u>.

After the medical exam

When your examination is completed, the doctor will provide you a copy of the vaccination worksheet by email or by post. For DV and K visa applicants, the panel physicians will send you the exam results in a sealed envelope. **DO NOT OPEN THIS ENVELOPE**. Instead, bring it to your visa interview. Any x-rays taken will be given to you. You **DO NOT** need to bring the x-rays to your visa interview. However, you **must** carry the x-rays with you when you travel to the United States for the first time.

Sending documents to the U.S. Embassy

If the consular officer asks you to submit additional documents to the U.S. Embassy, please follow any instruction given by an interviewer.

Rescheduling or cancelling your interview

If you are unable to attend your appointment, please use the embassy's <u>Interview Request Form</u> to ask for a new appointment date. **There may be a significant wait before the next available appointment**, so please attempt to attend the date already assigned. For some family-based and employment preference visa categories, a visa became available within the month you have been scheduled by NVC. DV applicants should be aware that visas are numerically limited and must be issued by September 30 of the program year. **There is no guarantee that a visa will still be available on the date of your rescheduled interview.** Please consult the <u>Visa Bulletin</u> before you decide to reschedule your interview.

Security screening procedures

All visitors to the U.S. Embassy in Tokyo must follow certain security procedures. Any visitor who declines to be screened by U.S. Embassy security personnel will be unable to enter the embassy. To avoid delaying your entry and that of those in line behind you, please bring only what is required for your interview. Accompanying persons

The following persons may accompany a visa applicant to their interview:

• Special Needs Visitors: Applicants may bring ONE person to help if they are elderly, disabled, or a minor child.

Attorneys are **not** permitted to accompany clients into the waiting room or to their interview.

Immigrant visa fees

If you have not paid all required fees to the National Visa Center, please be prepared to pay these fees on the day of your interview.

All fees may be paid in either Yen or U.S. dollars. We accept cash, credit cards (Visa, Mastercard, Discover, American Express, Diner's Club, and JCB) and U.S. postal money order payable to "U.S. Embassy, Tokyo." *Please note that if you are found ineligible to receive a visa, the application fee cannot be refunded. A* complete list of fees can be found <u>here</u>. Please also be prepared to pay with cash in case the credit card verification system is unavailable. Payment by credit card is billed in U.S. dollars.

Do not make travel plans outside of Japan

If your visa is approved, we will keep your passport at the embassy while we prepare your immigration packet and print a visa for your passport. We will return your passport to you later via mail only. If you have to travel within Japan while your passport is still with us, please make sure you have a valid picture ID other than your passport.

After Your Visa Interview

A consular officer can make a decision on a visa application only after reviewing the formal application and interviewing the applicant. *There is no guarantee that you will receive a visa.* Do not sell your house, car or property, resign from your job or make non-refundable flight or other travel arrangements until you have received your immigrant visa.

If more information is needed

Sometimes a consular officer is unable to make a decision on a visa application because he/she needs to review additional documents or the case requires further administrative processing. *When additional documents are requested,* the consular officer will give you a letter asking you to submit additional items. The letter will include instructions on how to submit those documents to the embassy. *Administrative processing* takes additional time after the interview. Most administrative processing is resolved within 60 days. However, the timing varies based on the circumstances of each case. Before inquiring about the status of administrative processing, please wait **at least** 60 days after your interview.

What happens after visa approval

Passport, Visa, and Sealed Immigrant Packet – We will place your immigrant visa in your passport. Please review your visa to make sure there are no spelling errors. Some applicants may receive a sealed envelope containing documents that you must give to U.S. immigration authorities when you arrive in the United States. *Do not open this envelope. You must carry it with you; do not put it in your checked luggage.* After your medical exam, only DV and K visa applicants will receive X-rays on a CD. Bring it with you when you enter the United States on your immigrant visa.

USCIS Immigrant Fee – All individuals who are issued immigrant visas overseas must **pay an <u>Immigrant Fee</u>** to U.S. Citizenship and Immigration Services (USCIS) *prior to traveling* to the United States. This fee is for processing your residency status and printing your Permanent Resident Card. The only people exempt from paying this fee are: children entering the United States under the Hague and Non-Hague Adoption Process, Returning Residents (SB-1), Iraqi and Afghan Special Immigrants and people traveling on a K visa.

When You Should Travel – You must enter the United States *before* the expiration date on your visa, which is usually six (6) months from the medical exam. Your visa cannot be extended and all fees are nonrefundable. The principal applicant must enter **before or at the same time** as other family members with visas. Unless they are eligible for benefits under the Child Status Protection Act, children who are issued a visa before turning 21 years of age must enter the United States *before* their 21st birthday to avoid losing their immigrant status.

Getting a Green Card – Your Form I-551 Permanent Resident Card, also known as a green card, will be automatically mailed to the address in the United States that you write in your visa application form. This is a very important document that proves you have permission to reside in the United States. We also recommend you check with the airline to ensure you are in compliance with their rules. Once your card is issued, you should not stay outside of the United States for more than one year. If you do, you will lose your status as a Lawful Permanent Resident.

Children's Issues – In the United States, children are required to have certain vaccinations before they can enroll in school. We recommend that you bring your child's complete vaccination records with you to the United States. If your child is adopted, you have full custody as a result of a divorce, or you share custody with another parent, you should bring a copy of all applicable adoption or custodial papers from the authoritative court in your home country. You will need these papers (translated into English) for issues such as school enrollment, medical care, and eventual citizenship.

Diversity Visa Applicants – Additional Information

If you are interviewing for a Diversity Visa (DV), all of the above instructions apply to you. Please schedule and attend a <u>medical examination</u> prior to your visa interview and gather the <u>required documents</u>.

Below are additional instructions that apply only to DV applicants.

Bring to your interview

In addition to the documents listed on the Pre-Interview Checklist in this package, DV applicants should also bring the following items to your visa interview:

Documents showing that you have either a qualifying high school education **OR** have two years of qualifying work experience in the last five years immediately prior to application (for the principal applicant only; more information is available <u>online</u>).

Payment in cash, or a U.S. postal money order, by credit card (VISA, MasterCard, Diners Club, JCB or American Express) for the \$330 Diversity Visa Application Fee

Overcoming Public Charge: The Immigration and Nationality Act requires all immigrant visa applicants to establish to the satisfaction of a consular officer at the time of the application for a visa, and also to the satisfaction of an officer of the Department of Homeland Security at the time of application for admission to the United States, that he/she is not likely to become a public charge.

Review your DV Lottery entry

Prior to your visa interview, we recommend that you review the data on your initial E-DV entry. On your initial E-DV application, you must have correctly entered your marital status. If you are legally married you must have listed your spouse, even if you are currently separated from him/her (unless your spouse is a U.S. citizen or Lawful Permanent Resident).

Additionally, you must have listed ALL of your living children who are unmarried and under 21 years old. This includes your natural children, your spouse's children, or children you have formally adopted in accordance with the laws of your country (unless your children are a U.S. citizen or Lawful Permanent Residents).

Failure to have listed an existing spouse or children at the time of your entry in the Diversity Visa lottery will result in the denial of your visa and visas for your family. Any fees paid to the U.S. government in support of your visa application(s) are nonrefundable. If you failed to include a child who had already been born, or a spouse to whom you were married when you entered the lottery, you should not proceed with the visa application. You can review the eligibility requirements <u>online</u>.
