Please follow the steps below *before* your immigrant visa interview at the Consular Section of the U.S. Embassy in Tunis, Tunisia.

Step 1: Register your appointment online

All Immigrant Visa applicants must create a profile on www.ustraveldocs.com, provide their correct contact details, and select their document return preference.

1. Please visit www.ustraveldocs.com, select your post and select 'Immigrant Visa'.
2. Select the green 'Visa Login' button and sign up for an account if you don't already have one.
3. In your account profile, please enter your **accurate** contact information (email and mobile phone).
4. Select "IV Address Registration" from the Post Visa Category selection.
5. Choose your document return preference.
6. Upon completion of the process, you will receive confirmation that you have successfully completed the process.

If you fail to create a profile in www.ustraveldocs.com and provide your contact information, you will face delays in receiving your documents.

Medical Exam Instructions



All immigrant visa applicants, regardless of age, require a medical examination prior to the issuance of a visa. Only a physician accredited by the U.S. Embassy can perform this exam. **It is your responsibility to schedule a medical exam with a doctor listed below before your visa interview appointment** at the U.S. Embassy. Medical examination results from other physicians will **not** be accepted. The doctors will advise you about required x-ray and blood analysis at embassy approved clinics.

Items to bring to your medical examination

You must pay all medical examination fees, including x-ray and blood test fees, directly to the examining physicians and/or labs. Bring the following items to your medical exam:

- Your visa interview appointment letter,
- Your passport,
- Four (4) recently taken passport-sized color photographs, and
- A copy of your immunization records.
- DS-260 confirmation page

During the medical exam

The medical examination will include a medical history review, physical examination, chest X-ray, gonorrhea test, and blood test (for applicants 15 years of age or older). The United States also requires tuberculosis (TB) testing for all applicants two years of age and older. Please be prepared to discuss your medical history, medications you are taking, and any current treatments. U.S. immigration law requires immigrant visa applicants to obtain certain vaccinations prior to the issuance of a visa. Current immigrant visa vaccination requirements are available on the [CDC website](#). After the medical exam

When your examination is completed, the doctor will either provide you with exam results in a sealed envelope or send them directly to the U.S. Consulate. **IF GIVEN AN ENVELOPE TO CARRY TO YOUR INTERVIEW, DO NOT OPEN THIS ENVELOPE. Instead, bring it to your visa interview.** Any x-rays taken will be given to you. You **DO NOT** need to bring the x-rays to your visa interview unless you suffer from tuberculosis. However, you **must** carry the x-rays with you when you travel to the United States for the first time. The medical report must be less than six (6) months old when you enter the United States as an immigrant.

Please use the list below to determine the items that every applicant must bring to the immigrant visa interview. Failure to bring all required documents to your interview appointment may result in the cancellation of your interview and the need to reschedule your appointment.

- ☐ A copy of your NVC interview letter (does not apply to Diversity Visa, fiancé(e), adoptive, or asylee/refugee applicants).
- ☐ Unexpired passport valid for six (6) months beyond your intended date of entry to the United States **and** a photocopy of the biographic page.
- ☐ Two (2) color photographs of each person applying for a visa (5 cm x 5 cm, or 2 inch x 2 inch). Please review our [online photo requirements](#).
- ☐ Confirmation page from the Form DS-260 Application for an Immigrant Visa you submitted online at ceac.state.gov/iv. Please submit your DS-260 at least two business days prior to your interview and ensure that all information is accurate and complete.
- ☐ Your **original** birth certificate. Your birth certificate should reflect your marital status.
- ☐ Your **original** marriage certificate (not marriage contract).
- ☐ Your **original (or certified)** divorce decree(s), **and/or your spouse's death certificate**. Photocopies **will not** suffice.
- ☐ Police certificate(s) for applicants over the age 16 for their country of current residence if they have lived there for at least six months, their country of nationality if they have lived there for at least six months, and any country they have lived in for more than one year since turning 16. Police certificates must be dated within two years at the time of the interview.
- ☐ Medical examination results in a sealed envelope (*if the physician gives you these results*).
- ☐ Original or certified copies of birth certificates for all children of the principal applicant (even if he or she is not accompanying).

Applicants who fall into any category listed in italics below should bring these additional documents:

For family-based visa applications:

- ☐ The appropriate [Form I-864 Affidavit of Support](#) for **each** financial sponsor along with a photocopy of the sponsor's IRS transcript for the most recent tax year. If the IRS Transcript is not available, please bring the most recent U.S. federal income tax return AND relevant W-2s from the most recent tax year.
- ☐ Proof of your U.S. petitioner's status and [domicile](#) in the United States (photocopy of a U.S. passport, naturalization certificate, or lawful permanent resident card).
- ☐ Evidence of the relationship between the petitioner and visa applicant (such as photographs, letters, or emails).
- ☐ *If you are married:* Your **original** marriage certificate (not marriage contract).
- ☐ *If you OR the petitioner were previously married:* All of your **original (or certified)** divorce decrees and/or your spouse's death certificate.

- ☐ *If you are 16 years of age or older:* The original police certificate for your country of current residence if you have lived there for at least six months, your country of nationality if you have lived there for at least six months, and any country you have lived in for more than one year since turning 16. You may need to bring in more than one police certificate. Police certificates must be dated within two years at the time of the interview.
- ☐ *For employment-based visa applications:* Letter from your U.S. employer dated less than one month ago.
- ☐ *If you have ever been convicted of a crime:* **Original (or certified)** court and criminal records.
- ☐ *If you have served in any country's military:* **Original (or certified)** military records.
- ☐ *If you are adopted:* **Original (or certified)** adoption papers or custody documents.
- ☐ *If you are the petitioner's stepchild:* The **original** marriage certificate of the petitioner and your biological parent, along with the **original (or certified)** divorce records for any previous marriages of either parent.

Interview Guidelines



Sending documents to the U.S. Embassy in Tunis

If the U.S. Embassy requests additional information or documentation from you, the consular officer will provide instructions on how to submit those to the embassy.

Rescheduling or cancelling your interview

If you are unable to attend your appointment, please email TunisIV@state.gov as soon as possible with your name, case number, original interview date, and reason for rescheduling. Someone will respond to your inquiry within three (3) business days. Please note that requests to reschedule appointments must be made at least one week before the scheduled appointment. **There may be a significant wait before the next available appointment**, so please attempt to attend the date already assigned.

For some family-based and employment preference visa categories, visas become available within the month you have been scheduled by NVC. DV applicants should be aware that visas are numerically limited and must be issued by September 30 of the program year. **There is no guarantee that a visa will still be available on the date of your rescheduled interview.** Please carefully consult the [Visa Bulletin](#) before you request to reschedule your interview.

Security screening procedures

All visitors to the U.S. Embassy in Tunis must follow certain security procedures. Any visitor who declines to be screened by U.S. Embassy security personnel will be unable to enter the embassy. To avoid delaying your entry and that of those in line behind you, please bring only what is required for your interview.

Accompanying persons

Attorneys are not permitted to accompany clients into the waiting room or to their interview. Only the following persons may accompany a visa applicant to their interview:

- Interpreter: Applicants may bring ONE interpreter if they do not speak English, French, or Arabic well enough to participate in an interview.
- Special Needs Visitors: Applicants may bring ONE person to help if they are elderly, disabled, or a minor child.

Immigrant visa fees

If you have not paid all the required fees to the National Visa Center, please be prepared to pay these fees on the day of your interview. All fees may be paid in either U.S. dollars or the Tunisian dollar equivalent. We accept cash and credit cards only. *Please note that if you are found ineligible to receive a visa, the application fee cannot be refunded.* This is a complete [list of fees](#).

Do not make travel plans outside of Tunisia

If your visa is approved, we will keep your passport while we prepare your immigration packet and print a visa for your passport.

After Your Visa Interview



A consular officer can make a decision on a visa application only after reviewing the formal application and interviewing the applicant. ***There is no guarantee that you will receive a visa.*** Do not sell your house, car or property, resign from your job or make non-refundable flight or other travel arrangements until you have received your immigrant visa.

If more information is needed

Sometimes a consular officer is unable to make a decision on a visa application because he/she needs to review additional documents or the case requires further administrative processing. *When additional documents are requested*, the consular officer will give you a refusal letter that asks you to submit additional documents. The letter will include instructions on where and how to submit those documents.

Administrative processing takes additional time after the interview. Most administrative processing is resolved within 60 days. However, the timing varies based on the circumstances of each case. Before inquiring about the status of administrative processing, please wait **at least 60 days** after your interview.

What happens after visa approval

Passport, Visa, and Sealed Immigrant Packet – We will place your immigrant visa on a page in your passport. Please review your visa to make sure there are no spelling errors. We will also give you a sealed envelope containing documents that you must give to U.S. immigration authorities when you arrive in the United States for the first time. **Do not open this envelope. You must carry it with you; do not put it in your checked luggage.** If you receive X-rays during your medical examination, carry those with you and give them to the U.S. immigration authorities.

USCIS Immigrant Fee – All individuals who are issued immigrant visas overseas must **pay an Immigrant Fee** to U.S. Citizenship and Immigration Services (USCIS) **prior to traveling** to the United States. This fee is for processing your residency status and printing your Permanent Resident Card. The only people exempt from paying this fee are: children entering the United States under the Hague Process, returning residents, and people traveling on a K visa.

When You Should Travel – You must enter the United States *before* the expiration date on your visa, which is usually six months from the date of printing. Your visa cannot be extended and all fees are nonrefundable. The principal applicant must enter **before or at the same time** as other family members with visas. Unless they are eligible for benefits under the Child Status Protection Act, children who are issued a visa before turning 21 years of age must enter the United States *before* their 21st birthday to avoid losing their immigrant status.

Getting a Green Card – Your Form I-551 Permanent Resident Card, also known as a green card, will be automatically mailed to the address in the United States that you write in your visa application form. This is a very important document that proves you have permission to reside in the United States. *Do not travel outside of the United States until you receive your Permanent Resident Card. Once your card is issued, you should not stay outside of the United States for more than one year. If you do, you will lose your status as a Lawful Permanent Resident.*

Children's Issues – In the United States, children are required to have certain vaccinations before they can enroll in school. We recommend that you bring your child's complete vaccination records with you to the United States. If your child is adopted, you have full custody as a result of a divorce, or you share custody with another parent, you should bring a copy of all applicable adoption or custodial papers from the authoritative court in your home country. You will need these papers (translated into English) for issues such as school enrollment, medical care, and eventual citizenship.

Diversity Visa Applicants – Additional Information



If you are interviewing for a Diversity Visa (DV), all of the above instructions apply to you. Please schedule and attend a medical examination prior to your visa interview, and gather the required documents.

*Below are additional instructions that apply **only** to DV applicants.*

Bring to your interview

In addition to the documents listed on the Pre-Interview Checklist in this package, DV applicants should also bring the following items to your visa interview:

- Appointment information printed from the “Entrant Status Check” on the [E-DV website](#).
- Please bring photocopies of all documents.
- Documents showing that you have either a qualifying high school education OR have two (2) years of qualifying work experience in the last five (5) years immediately prior to application (for the principal applicant only; more information is available [online](#)).
- Payment in cash of the \$330 Diversity Visa Application Fee for each applicant.

Review your DV Lottery entry

Prior to your visa interview, we recommend that you review the data on your initial E-DV entry. On your initial E-DV application, you must have correctly entered your marital status. If you are legally married you must have listed your spouse, even if you are currently separated from him/her (unless your spouse is a U.S. citizen or Lawful Permanent Resident).

Additionally, you must have listed ALL of your living children who are unmarried and under 21 years old. This includes your natural children, your spouse’s children, or children you have formally adopted in accordance with the laws of your country.

Failure to have listed an existing spouse or children at the time of your entry in the Diversity Visa lottery will result in the denial of your visa and visas for your family. Any fees paid to the U.S. government in support of your visa application(s) are nonrefundable. If you failed to include a child who had already been born, or a spouse to whom you were married when you entered the lottery, you should not proceed with the visa application.
